Treasurer Report

ACA Revenue

- ACA's sources of revenue are limited.
- We have taken steps to balance our expenses and income.
- Membership dues remain constant
- Increased meeting registration fees
- Exhibitor booth space and sponsorships at Annual Meeting have been maximized
- ACA total investment values increased during 2023 due to the improvement in the stock market.

2023 Assets

- 2023 ACA assets showed
 - Operating income -- \$51,693
 - Non-operating income \$59,142
- Why
 - Additional AV at 2023 meeting expenses
 - Extra food costs at 2023 meeting (inflation)
- 2023 and 2024 were good stock market years
- Food well received this year

 - 2022 a lot of money lost paper losses in investments

- Council has been actively working on adopting strategies for increasing/maintaining membership and meeting attendance

Finance Committee Initiatives

- The ACA Investment Policy Statement has been implemented and is being followed
- Annuity investments (2008, 2009) that are coming due in 2024 and later are being reinvested in Vanguard funds which should have higher return

 Co-sponsor the IUCr 2026 Congress in Calgary, Canada along with Canadian National Committee and US National Committee

Finance Summary

- We were in the red during 2012-2018. The trend was reversed and we have been in the black in 2019 (\$103,000), 2020 (\$256,732), 2021 (\$206,568), 2022 (\$112,268), 2023 (\$7,450)
- GOAL: to stay cash flow positive; use reserves dividends to rebuild reserves equal to three year expenses
 ~\$500,000/year.
- Meeting attendance up this year @555 (at beginning of July)
